This metallic flooring provides a very unique floor finish that has uniform color shift and movement that can be modified by the installer. The 4750 Lava Flow ® Epoxy is designed to be an easy to install product that can offer very similar results each time it is applied. It also exhibits great chemical and wear resistance. This can be used as a stand-alone metallic epoxy flooring sealer and does not require a separate topcoat. However, an additional topcoat maybe applied if desired to protect it from scuffing, walk-off patterns, or to increase UV resistance for a long-lasting finish.

#### **TEMPERATURE**

Product was tested at ambient temperature (75°F-77°F). Results <u>WILL</u> vary when product is used at temperatures different from testing temperature. The pot life, gel time, and cure time is generally longer for colder temperature applications, and shorter for higher temperature applications. Physical properties are also impacted and dependent upon temperature.

#### **MAINTENANCE**

Maintain the 4750 to a minimum thickness of 10 dry mils. If the 4750 is damaged, it can be repaired by sanding the surface, cleaning and then recoating the area with same materials.
